

**GENERAL RELEASE, WAIVER OF CLAIM,
ASSUMPTION OF RISK, AND INDEMNIFICATION**

By signing below, I, on my own behalf and on behalf of my guests, my children, and/or other persons, including minors, for whom I am responsible ("My Guests"), acknowledge that by executing this document, I fully understand and agree to the following:

1. The premises at which the business is located (the "Premises") contains dangerous amusement devices and activities (the "Entertainment Devices"), which may result in injury to me, as well as My Guests.

2. It is my responsibility to ensure the safety of me and My Guests utilizing the Entertainment Devices and Premises, including the following: a) continuously monitoring My Guests using the Entertainment Devices and the Premises; b) ensuring only the proper number of people use the Entertainment Devices at one time; c) ensuring the Entertainment Devices are used in the manner for which they were designed; d) ensuring the Entertainment Devices are not used by persons who are susceptible of being injured, including, but not limited to, babies and elderly persons; and e) ensuring all rules, regulations, and warnings concerning the Entertainment Devices and the Premises, and the potential for injury and/or death, are understood and strictly followed by all persons using and/or near the Entertainment Devices, including, but not limited to, in the case of minors using and/or near the Entertainment Devices, their parent or guardian.

3. I acknowledge that that the rental, use, misuse, attempted use, inflation, deflation, collapse, and/or operation of the Entertainment Devices, and me and My Guests' presence at the Premises, involves a risk of serious injury or death by me and My Guests.

4. I voluntarily assume any and all risk, including harm and/or death to me and my property, as well as harm and/or death to My Guests and/or their property, which may be caused as a result of the rental, use, misuse, attempted use, inflation, deflation, collapse, and/or operation of the Entertainment Devices, and/or our presence at the Premises.

5. In consideration of Absolute Fun Center, LLC permitting me and My Guests to rent and/or use the Premises and Entertainment Devices, I voluntarily release, waive, and discharge Absolute Fun Center, LLC, its owners, operators, members, employees, officers, agents, representatives, administrators, heirs, successors, assigns and/or any other person, firm, corporation or business entity, who are or may be held liable for any acts or omissions of Absolute Fun Center, LLC ("Absolute Fun"), from any and all claims, demands, damages, both compensatory and punitive, costs, attorney's fees, actions and causes of action whether arising at law or in equity, *INCLUDING ANY AND ALL CLAIMS ON ACCOUNT OF ANY NEGLIGENCE OR OTHER FAULT ON THE PART OF ABSOLUTE FUN*, which I or My Guests may have against Absolute Fun for, on account of, or by reason of the rental, use, misuse, attempted use, inflation,

deflation, collapse, and/or operation of the Entertainment Devices, and/or my or My Guests' presence at the Premises.

6. In consideration for Absolute Fun permitting me and My Guests to rent and/or utilize the Entertainment Devices and Premises, I voluntarily agree to indemnify and hold harmless Absolute Fun from and against any loss, cost, damage, claim, cause of action, expense, demand, and/or attorneys' fees, in any way occasioned by or arising out the rental, use, misuse, attempted use, inflation, deflation, collapse, and/or operation of the Entertainment Devices and/or the presence at the Premises by me and/or My Guests.

7. I am of sound mind and not under the influence of alcohol or any other intoxicant and execute this GENERAL RELEASE, WAIVER OF CLAIM, ASSUMPTION OF RISK, AND INDEMNIFICATION AGREEMENT (this "Agreement") of my own free will and accord.

8. I acknowledge that this Agreement extends to all acts and/or omissions by Absolute Fun, and is intended to be as broad and inclusive as permitted by the laws of the State of Rhode Island, and that if any portion is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

9. I have read this Agreement, fully understand its terms, understand that I have given up substantial rights by signing it, am aware of its legal consequences, and have signed it freely and voluntarily without any inducement, assurance, or guarantee being made to me or My Guests, and intend my signature to be a complete and unconditional release of all liability and indemnification obligation to the greatest extent allowed by law.
